The certificate of conduct is a minimum entry requirement set for any operator within JKIA.
6.	On the financial requirements we wish to propose 10,000/- for all categories i.e. maxi cabs and standard taxis.	The concession fee set is based on the vehicle seat capacity. The maxicab being of higher seating capacity shall therefore be charged a concession of Ksh. 15,000 per month while the standard cab will be charged Ksh. 10,000 per month.
