1.	<p>We refer to the above-mentioned tender and, in particular, to Mandatory Requirement No. 16 which requires the submission of a valid EPRA License — specifically a V1/V2 (Solar contractor/vendor/importer) license.</p> <p>We respectfully wish to seek clarification regarding this requirement.</p> <p>Based on our review of the tender documents and the scope of works described — which primarily involves the supply and installation of Uninterruptible Power Supply (UPS) systems — we note that the works fall predominantly under electrical installations, and do not include any solar components or related systems that would necessitate a V1/V2 EPRA license.</p> <p>Accordingly, we kindly request your consideration and approval to allow submission of a valid EPRA license for Electrical Works, which we believe is the appropriate and relevant license category for this scope.</p>	<p>Under mandatory evaluation criteria No. 17</p> <p>Submission of valid EPRA License (Company's Valid EPRA license V1/V2 – Solar contractor/vendor/ importer)</p> <p>This requirement is hereby expunged and shall not be used as evaluation criteria</p>
2.	<p>The upload of the tender document was done after 1st April, 2025 and its indicated in the document that site visit is mandatory.</p> <p>Please clarify and if mandatory we request you provide us with new dates</p>	<p>Site visit is a Mandatory requirement</p> <p>Bidder are hereby informed that the another Pre-bid/Site visit shall be held on Monday 14th April 2025 10.00 am at Kisumu International Airport</p>
