The following are tender clarifications/addendum issued regarding the above tender in accordance to instructions to tenderers Clause 10.1 of the bidding document for the referenced tender:

1.	Please clarify the below. Tender Security is indicated in words as five hundred thousand Kenya Shillings (Ksh. 500,000) whereas in figures it has been indicated as Ksh. 200,000 (Two Hundred	The Authority hereby amends tender security in words to Read "Two Hundred Thousand Kenya Shillings (Kshs. 200,000)" in the entire tender instead of Five Hundred Thousand.
2.	Thousand Kenya Shillings) the tender document, particularly Part I – Preliminary Evaluation – Item 18, we note that it requires the submission of a valid National Construction Authority (NCA) Registration Certificate and a valid practicing license for Electrical Services Installations, specifically limiting eligibility to firms within NCA Category 4 to 5. We respectfully seek clarification and request a review of this requirement. As currently stated, the clause appears to unintentionally exclude eligible bidders who are registered under higher categories (i.e., NCA 1 to 3) despite possessing the requisite qualifications, experience, and	The requirement of NCA will remain as per the tender.

capacity to undertake the project. It is our understanding that higher NCA categories (NCA 1 to 3) meet and often exceed the requirements set for categories 4 and 5, and as such, should not be excluded from participating. Restricting the tender to only NCA 4 and 5 may limit competition and potentially affect the quality and pricing of bids received. In view of the above, we kindly request that KAA revises this requirement to accommodate all bidders with valid NCA registration in Electrical Services Installations from category 1 to 5, or provides further clarification if there is a specific reason for the limitation.

The closing/opening date is hereby extended to 24<sup>th</sup> April, 2025 at 11.00 a.m. from 16<sup>th</sup> April, 2025 at 11:00 am.

Kindly ensure your tender is valid for a period of 186 days and your tender security is valid for a period of 216 days from the NEW closing/opening date of 24<sup>th</sup> April, 2025 at 11.00. a. m.

This addendum forms part of the bidding document and is binding on all bidders. All other conditions remain the same.
